Consent for Purposes of Treatment, Payment and Healthcare Operations

My "protected health information" means health information, including my demographic information, collected from me and created or received by my physician, another health care provider, a health plan, my employer or a health care clearinghouse. This protected health information relates to my past, present or future physical or mental health or condition and identifies me, or there is a reasonable basis to believe the information may identify me.

I understand I have a right to review <u>Virginia Center for Reproductive Medicine</u> 's Notice of Privacy Practices prior to signing this document. The <u>Virginia Center for Reproductive Medicine</u> 's Notice of Privacy Practices has been provided to me. The Notice of Privacy Practices describes the types of uses and disclosures of my protected health information that will occur in my treatment, payment of my bills, or in the performance of health care operations of the <u>Virginia Center for Reproductive Medicine</u>. This Notice of Privacy Practices also describes my rights and the <u>Virginia Center for Reproductive Medicine</u> 's duties with respect to my protected health information.
